Important information to note:

General Conditions

- ✓ The NCE vehicle is strictly for use by an NCE Member organisation for official non-commercial work.
- ✓ The vehicle remains the property of the NCE and shall be managed according to the information outlined in this document.
- ✓ The driver shall ensure that all laws, safety procedures and good road etiquette are always adhered to. Unless indicated to the contrary, the maximum speed on all rural main (tarred) roads is 120 km/hr, gravel roads is 80 km/hr, and in urban areas, rural villages and near schools is 60 km/hr. But ultimately, the onus is on the driver to select the correct speed for the prevailing circumstances.
- ✓ When not in use, the user shall ensure that the vehicle is stored at a safe place.
- ✓ Only authorized drivers may drive the vehicle.
- ✓ An up-to-date logbook is to be kept. A logbook is provided in each vehicle.
- ✓ Daily checks must be done (e.g. water, oil, break and clutch fluid levels, tyre pressures)
- ✓ Any damage or obvious defects to the vehicle must be reported to the NCE immediately.
- ✓ Any damage that is not reported immediately will be the liability of the user.
- ✓ No lifts may be given to people not involved with the work of the organization.
- ✓ All passengers in the vehicle must complete and sign Indemnity Forms which must be held by the Member Organization and provided to the NCE on request. If the Member Organization has their own Indemnity Form

Costs

- ✓ The user is responsible for fuel, oil, brake, clutch and power-steering fluid, and related running costs.
- ✓ The vehicle will be provided with a full tank of fuel. Vehicles must be returned with a full tank of fuel.
- ✓ The NCE is responsible for insurance of the vehicle and for payment of premiums and annual license renewal.
- ✓ The NCE shall be responsible for maintenance and general up-keep of the vehicle.
- ✓ The NCE shall be responsible for any costs that can be attributed to mechanical failure due to normal usage for which the vehicle was designed.
- ✓ The user is to contact the NCE if such a mechanical failure should occur to obtain authorization to have repairs carried out as soon as possible.
- ✓ The user is responsible for all fees and fines (including, but not limited to, speeding tickets, parking tickets, etc.) relating to use of the vehicle.

Accidents

- ✓ Any accidents must be reported to the police (immediately) and NCE (within 24 hours).
- ✓ The user is responsible for the basic excess on the insurance policy in the event of an accident or damage to the vehicle, at the fault of the user or upon negligent or reckless driving.
- ✓ If the NCE's insurer refuses to meet a claim as a result of any action by the user allowing the insurer to void the claim (e.g. drunk driving, invalid license, negligence) then the user shall be responsible for the claim, or claims, in its, or their, entirety.

Liability

- ✓ Neither the NCE nor any donor(s) to the NCE shall be liable to the user or to any member of the user's staff, board, family or volunteers or any other person for any loss, liability, damage, injury or death of whatsoever nature, nor anything arising in relation (indirectly or directly) to the use of this vehicle.
- ✓ The NCE and any donors to the NCE are indemnified against and rendered harmless regarding any claims for any loss, liability, damage, injury or death which may be instituted against the NCE and all donors to the NCE in this regard.
